Volunteer Agreement

In consideration of this opportunity to volunteer, I agree to the following terms and conditions, intending to be legally bound by them.

1. I will abide by the mission, rules, regulations, policies, and programs of Friends For Life Animal Rescue, Inc. (FFL) while I am a volunteer.
2. If I stop being a volunteer for FFL for any reason, or upon FFL's request at any time, I will promptly return all of FFL's supplies, equipment, records, moneys, and other items in good, clean condition.
3. I assume the risks of being bitten, scratched, injured, or frightened by dogs, puppies, cats and kittens in connection with my volunteer work for FFL. FFL is not liable to me for any injuries, damages, liabilities, losses, judgments, costs, or expenses whatsoever, which I might suffer or sustain in connection with the performance of my volunteer activities for FFL unless they are the result of FFL's gross negligence or intentional misconduct. I will indemnify, defend, and hold FFL harmless from and against any claims, lawsuits, injuries, damages, losses, costs or expenses whatsoever, sustained by any companion animal or any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities for FFL, or my breach of FFL's rules, regulations, policies, and programs.
4. I understand and agree that FFL may refuse volunteer applications for any reason.
5. If I will be sheltering or providing foster care or boarding any of FFL's animals in my home or business, I consent to FFL visiting my home or business from time to time to observe the animals and their living quarters.
6. I have accurately and truthfully completed this Volunteer Application and Agreement.
7. Any modification to this Agreement must be in writing signed by both parties. This Agreement is binding upon FFL, me, and FFL's and my respective heirs, successors, assigns, executors, and personal representatives.
